As per the permission accorded by the National Medical Commission, New Delhi vide ref 3<sup>rd</sup> cited, as per the orders of the Vice-Chancellor, KNRUHS, Warangal vide 5<sup>th</sup> cited and as per the Statues on affiliation of Medical Colleges of Kaloji Narayana Rao University of Health Sciences, Warangal it is hereby certified that the application of *ESIC Medical College*, *Sanathnagar*, *Hyderabad* has been registered with KNRUHS, Warangal and provisional affiliation is granted to make admissions into 1st year MBBS Course with an intake of 125 (100 +25 towards implementation of EWS) seats at *ESIC Medical College*, *Sanathnagar*, *Hyderabad* for the academic year 2021-22.

The Institution / College is fully responsible to fulfill the norms and to maintain the same which includes infrastructure both physical and human resource, teaching faculty and clinical material, etc., throughout the academic year, as stipulated in regulations of National Medical Commission.

The number of students admitted shall not exceed the number of students permitted for annual admissions both under University and Management Quota as specified by the NMC / KNRUHS. The Fee collected by whatsoever name called either for University quota seats or for management quota seats should not exceed the limits specified by the State Government/Kaloji Narayana Rao University of Health Sciences, Warangal from time to time.
