### Madam/Sir,

In context of the above cited subject, it is brought to your kind attention that despite directives issued by Hqrs. office vide letter as cited under ref.-(iv) to the all ESIC/ESIS field units for coordinating with the respective hired solar agencies (M/s REIL/their Developers) for successfully installation of rooftop solar power plant, several instances of lack of coordination from the various ESIC filed units regarding Site Surveying, PPA signing, providing approvals, timely support for installation, etc. have been informed by M/s REIL which resulted in unwanted delay in completion of the aforementioned works. In this regard, it is brought out that all the coordination shall be provided by RO' Engineers for installation of Roof Top Solar Power project (RTSPP) works by M/s REIL in the respective State.

In this context, it is directed that respective Officer In-charge / Estate Officer may sign the PPA on top most priority so that RTSPP works is completed in a mission mode at remaining owned buildings of ESIC so that clean energy may be harnessed and the objectives of PM Surya Ghar scheme may be achieved by the end of year 2025.

Accordingly, Action Taken Report along with present status of <u>Implementation of rooftop solar power plant</u> is to be submitted within 15 days from issuance of this letter in following format.

#### Sir/Madam,

With reference to above cited subject & Hqrs. office earlier letters as above referred letter no. 1 & 2. In this continuation, it is to informed that the Government of India launched the PM Surya Ghar: Muft Bijli Yojana on 13th February 2024, which aims to popularise the adoption of rooftop solar in the country. One of the critical components of the scheme is to undertake the saturation of all Government buildings under the administrative control of Central Ministries (including autonomous bodies, subordinate offices, CPSEs etc.) with rooftop solar latest by end 2025. The Ministry of New and Renewable Energy (MNRE) is coordinating this effort on behalf of the Government of India. As approved by the Government, a Steering Committee headed by Cabinet Secretary will monitor the progress of the scheme, especially the saturation of Government buildings, and provide guidance for its successful implementation.

In view of above, it has been directed to achieve given scope of ambition of the target and the stringent deadline, an intensive effort needs to be undertaken on priority by all Ministries/Departments. For saturation of Roof Top Solar project, it is essential to initially list all buildings/complexes under the Ministry/Department/its attached bodies, make a baseline assessment of the total potential rooftop solar capacity based on the availability of appropriate roof space and technical requirements, rooftop solar capacity already installed and identify the gap to be filled.

In order to achieve and comply the above said direction, ESIC has renewed MoU (Copy attached) with M/s REIL. Now, REIL is working as Project Management Consultant (PMC), to undertake installation of grid connected Roof Top Solar Power plants (RTSPP) Project at all owned buildings of ESIC.

ESIC to collate and track the data of saturation of all buildings with rooftop solar, a dedicated section has been created in the National Portal for the scheme (pmsuryaghar.gov.in) for updating, monitoring and tracking the status of progress of installation of Rooftop Solar in

buildings of every Ministry/Department. Therefore, RTSPP is being implemented by REIL through their developer on RESCO Mode for which silent features already have been communicated vide this office earlier letter cited under reference no.1 (copy enclosed).

In this context Hqrs. Office vide letter cited under reference no.4 communicated that M/s REIL, has engaged developers by bidding process for 14 states under RESCO model and surveying of these 14 states is in progress by M/s. REIL. Further, it is directed to designate nodal officer (Senior most Engineer posted at Regional office) under intimation to this office for co-ordination with M/s. REIL and their developers as well as State run Hospitals and dispensaries for implementation of RTSPP at all ESIC owned buildings.

Therefore, it is requested that respective Officer In-charge /Estate Officer may sign the PPA on **top most priority** so that installation of Roof Top Solar Power project (RTSPP) is completed in a mission mode at remaining owned buildings of ESIC so that clean energy may be harnessed and the objectives of PM Surva Ghar scheme may be achieved.
