Sub: Amalgamation of old scheme MBBS students into the new CBME course curriculum.

Ref: Decision of the Syndicate in its 195th meeting held on 13.01.2025

The Syndicate of Rajiv Gandhi University of Health Sciences, Karnataka in its 195th meeting held on 13.01.2025 approved the proposal of amalgamation of old scheme MBBS Students into the new CBME as per the provisions provided by National Medical Commission (undergraduate Medical Education Board) in its circular No. U11026/1/2022-UGMEB dated 31.03.2022. This amalgamation is subject to the eligibility and acceptance of the changes in criteria for examination, eligibility criteria, subject of study, valuation criteria, result computation, passing criteria, number of attempts and maximum duration for completion of the course.

Pursuant to the decision of the Syndicate, the Director/Principals of RGUHS-affiliated Medical Colleges are hereby instructed to communicate the aforementioned decision to the RS3 scheme students and to submit a list of RS3 batch students from their respective colleges who are willing to amalgamate with the CMBE course curriculum in the following format by email to registrareva@rguhs.ac.in on or before 22.01.2025.

The students willing for amalgamation shall be covered and abide by the changes in criteria for examination, eligibility criteria, subject of study, valuation criteria, result computation, passing criteria, number of attempts and maximum duration for completion of the course and the curriculum of GMER-2021 published by National Medical Commission. The main changes in the said amalgamation are as follows:

06	There is no bar on maximum duration for completion of the course	The maximum duration for completion of the course is 10 years from the date of amalgamation. However, if the student is in first year he shall complete first year within 4 attempts/4 years.
