<sup>1.</sup> ESI, a social security and health scheme for Indian workers, is financed out of contributions from employees and ESIC manages corpus for more than 3 crore Insured Persons (IP).

<sup>2.</sup> IP Registration is not subject to mandatory Aadhaar seeding and, therefore, an employee may have multiple IP registration numbers due to change of employment

<sup>3.</sup> The stock number may also change due to the employees who have ceased to pay contribution. This may be due to wage exceeding the statutory ceiling of Rs.21000/- per month/resignation/death/ retirement/dismissal.

<sup>4.</sup> The stock of existing employees paying contributions for a given month is provisional for upto at least six months because of delayed filing of contributions/returns by the employers.
