Terms & Conditions:-

- 1. The bidder must have an experience of such work of silver services.
- 2. The service provider should have the Office or Registered Branch Office at Jaipur (Rajasthan).
- 3. The service provider/Bidder should have valid Registration/ Incorporation /Shop & establishment Act certificate of firm.
- 4. Bidder should have license regarding manufacturing and/or trading of silver.
- 5. The bidder firm should not have been indicted for any criminal, fraudulent or anti-competition activity and not been blacklisted by any Govt. Departments/ESIC/PSU/Govt. Hospital.
- 6. The bidder/firm must have PAN/TAN/GST Number and bank account with any Nationalized Bank/Scheduled commercial Banks.
- 7. Supplied Items should be of good standard quality only.
- 8. It will be the responsibility of the supplier to ensure that items supplied are of standard quality and free from any defects. The acceptance of items will be given only when Items are found as per ordered quantity and up to the satisfaction of inspection officer as well as in-charge. The decision the competent authority, ESIC Model Hospital Jaipur, shall be final as to the quality of the items and shall be binding upon Supplier. Supply which is found to be of lower quality will be rejected outright and it shall be replaced immediately at the risk and cost of by the supplier.
- 9. The items should have BIS, Hall mark and of best quality.
- 10. All supplies shall be delivered at the general branch at ESIC model hospital, Jaipur.
- 11. Quantity may increase or decrease depending upon the demand/consumption upto 25% of total quantity mentioned in Bid.
- 12. You will be solely responsible for quality of Silver.
- 13. We required 6 silver memento plus or minus 25% during tender period.
- 14. The requirement of the silver memento will be sent to you on quarterly basis and SOS (as and when required)
- 15. You have to fulfill the requirement within 05 days after issuance of work order.
- 16. You will be solely responsible to follow all government guidelines
- 17. Silver rate will be paid as per the day rate on the date of sanction order issued.
- 18. BIS Hallmarking should be there for authenticity for the silver.
- 19. Prices quoted shall be fixed during the period of the contract including any extended period and not subject to any variation and TDS/GST will be deducted as per rules. Advance payment will not be made under any circumstances.
- 20. All documents mentioned in annexure-I should be self-attested and submitted in sealed envelope at General branch, ESIC Model Hospital, Jaipur till last submission date mentioned in bid documents.
