This is the **second advertisement** issued in continuation of the earlier advertisement dated **28.08.2024**, inviting applications from Hospitals, Diagnostic Centers, Dialysis Centers, Blood Banks, IVF, and Eye Centers located within the State of Karnataka for empanelment under ESIC.

- Such hospitals may now be **either NABH fully accredited or empanelled under PMJAY** (Ayushman Bharat – Pradhan Mantri Jan Arogya Yojana).
